### Parent/Guardian Consent Form

We are requesting permission for your child's photo/image and carefully selected personally identifiable information when appropriate to be published on the district and/or school's web site or video broadcasts or in print media generated by the school district.

As you are aware, there are potential dangers associated with the posting of information, identifiable or not, on a web site since global access to the Internet does not allow us to control who may access such information. These dangers have always existed; however, we as a school district do want to celebrate your child, his/her work, and his/her participation in certain programs or events.

The district will not release any personally identifiable information without prior written consent from you as parent or guardian, that includes the name of your child or the school where he/she attends, grade level, or the date and place of a particular event. Often opportunities arise where group images such as at a sporting event or during an assembly or play could appear on a district or school web site, on a video offering, on the local Channel 20 television broadcast, or in print media generated by the school district. In these cases, there is no identifiable information other than generic qualifiers, as Ms. Doe's class or the high school football game participants.

Permission is granted for a photo/image of my child and all other personal identifiers such as name, age, grade, school, and class are allowed to be included on the district or school's web site, on video and televised broadcasts, or in print media generated by the school district. (No address, no email address will be included.)

Permission is granted for a photo/image of my child, but no other personally identifiable information may be published on the district's public web site, school site, on video or televised broadcasts, or in print media generated by the school district. I will allow my child to participate in photograph sessions or group pictures such as assembly programs, sporting events, and class events, but with no other personal information provided to the media. (This would include visits to the television studios at the high schools where broadcasts and videos contain only the photo image of students but no other identifying information of each participant would be made available.) Permission is granted for a photo/image of my child and all other personal identifiers such as name, age, grade, school, and class are allowed to be included on the district or school's web site, on video and televised broadcasts, or in print media generated by the school district. (No address, no email address will be included.)
